Total Nonfarm Employment Increased by 51,100 Jobs Year Over Year in October 2023 Arizona Unemployment Increased to 4.2%

The Arizona seasonally adjusted (SA) unemployment rate increased to 4.2% in October 2023 from 4.0% in September 2023. The U.S. SA unemployment rate increased to 3.9% in October 2023 from 3.8% in September 2023.

Month over month, Arizona's SA labor force increased by 10,242 individuals, or 0.3%. Year over year, the SA labor force increased by 77,818 individuals, or 2.1%.

Month over month, Arizona not-seasonally adjusted (NSA) total nonfarm employment increased by 17,200 jobs. Year over year, NSA total nonfarm employment increased by 51,100 jobs, or 1.6%. Arizona SA total nonfarm employment lost 1,200 jobs month over month.

Month Over Month

Arizona NSA nonfarm employment increased by 17,200 jobs in October. Prior to the pandemic (2010-2019), NSA nonfarm employment gained 27,800 jobs on average in October. The private sector recorded a gain of 14,700 jobs in October, led by gains in Trade, Transportation & Utilities (9,500 jobs) and Private Education & Health Services (6,200 jobs). Prior to the pandemic (2010-2019), private sector employment averaged a gain of 24,500 jobs in October. The government sector¹ recorded a gain of 2,500 jobs in October, less than the pre-pandemic (2010-2019) average gain of 3,300 jobs. Employment gains in the government sector occurred primarily within State Government (1,700 jobs).

- Leisure & Hospitality (700 jobs)

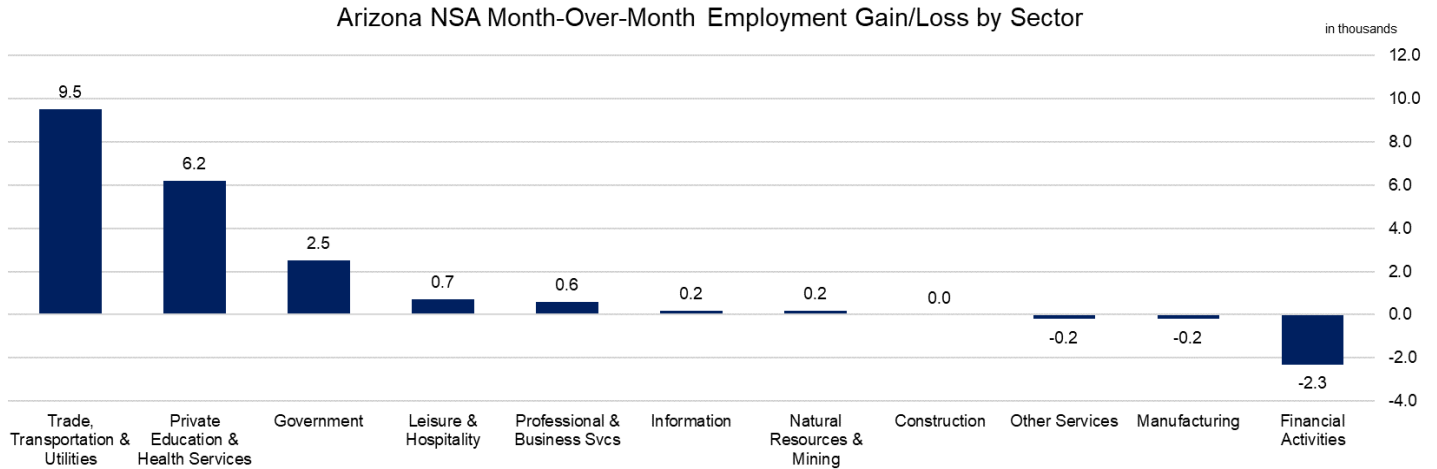

Year Over Year

Arizona NSA nonfarm employment increased by 51,100 jobs or 1.6% in October year over year. Private sector employment increased by 33,700 jobs year over year, while government employment increased by 17,400 jobs year over year.

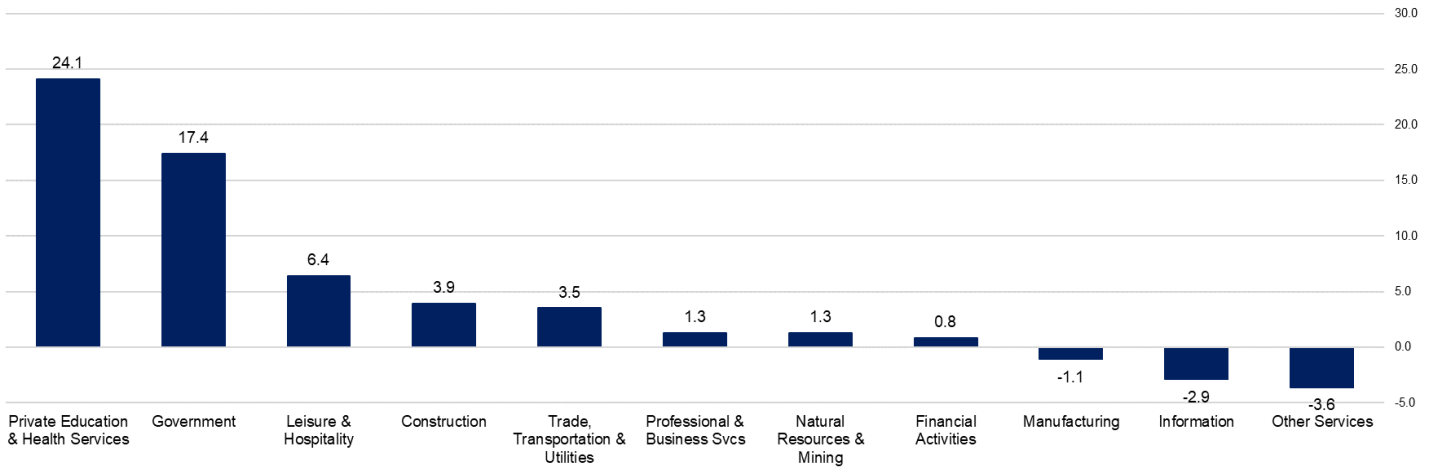

Arizona NSA Year-Over-Year Employment Gain/Loss by Sector

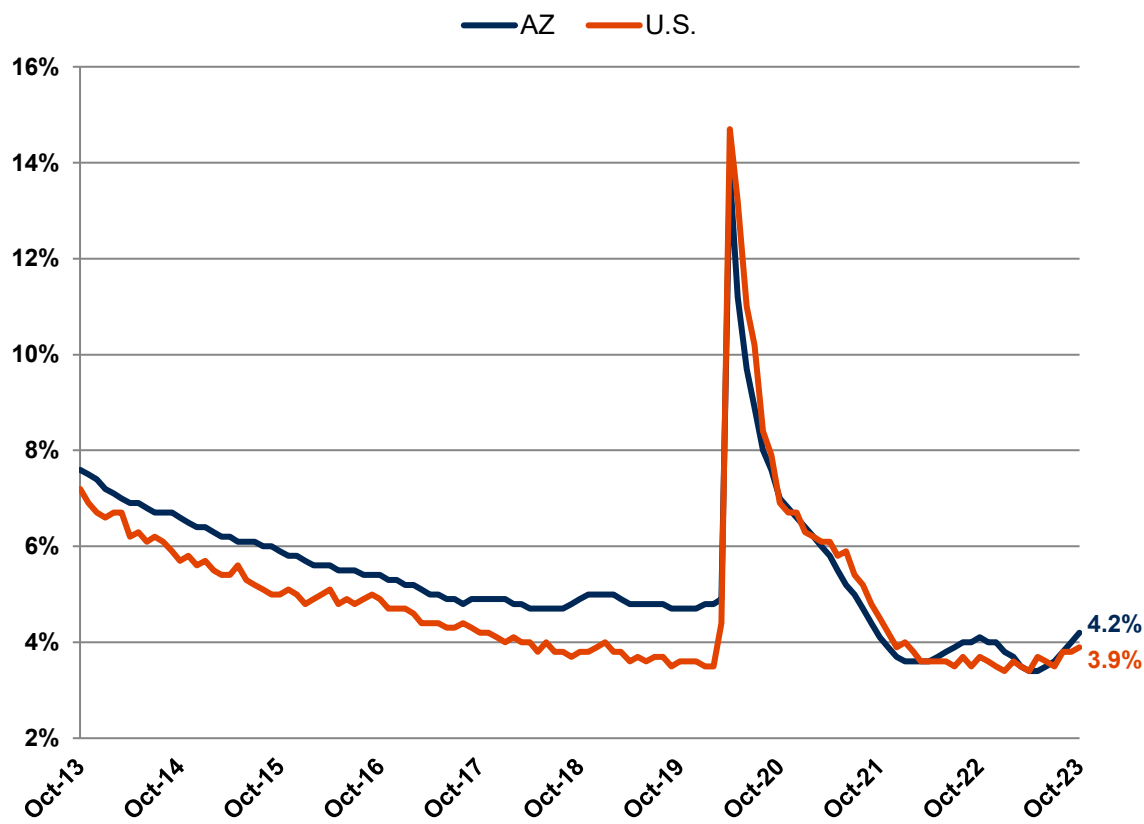

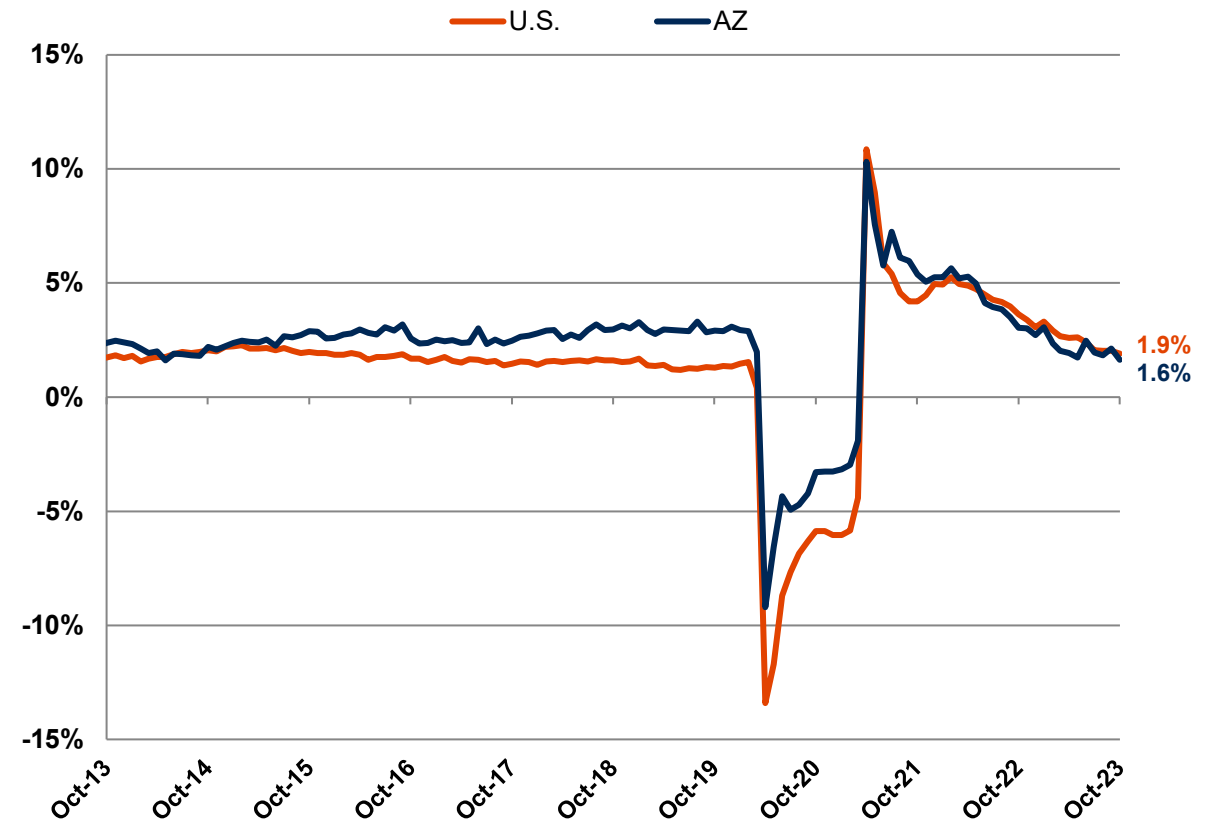

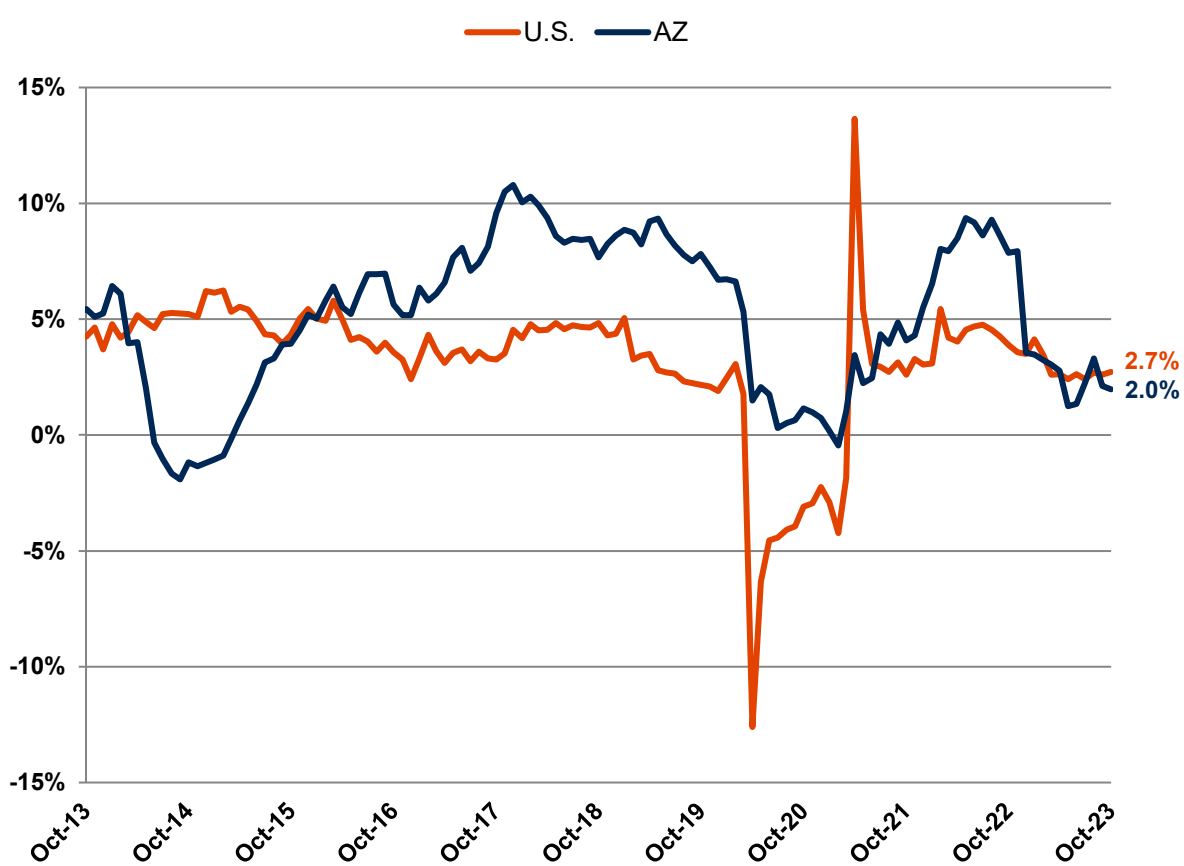
Arizona & U.S. Unemployment Rate
Seasonally Adjusted



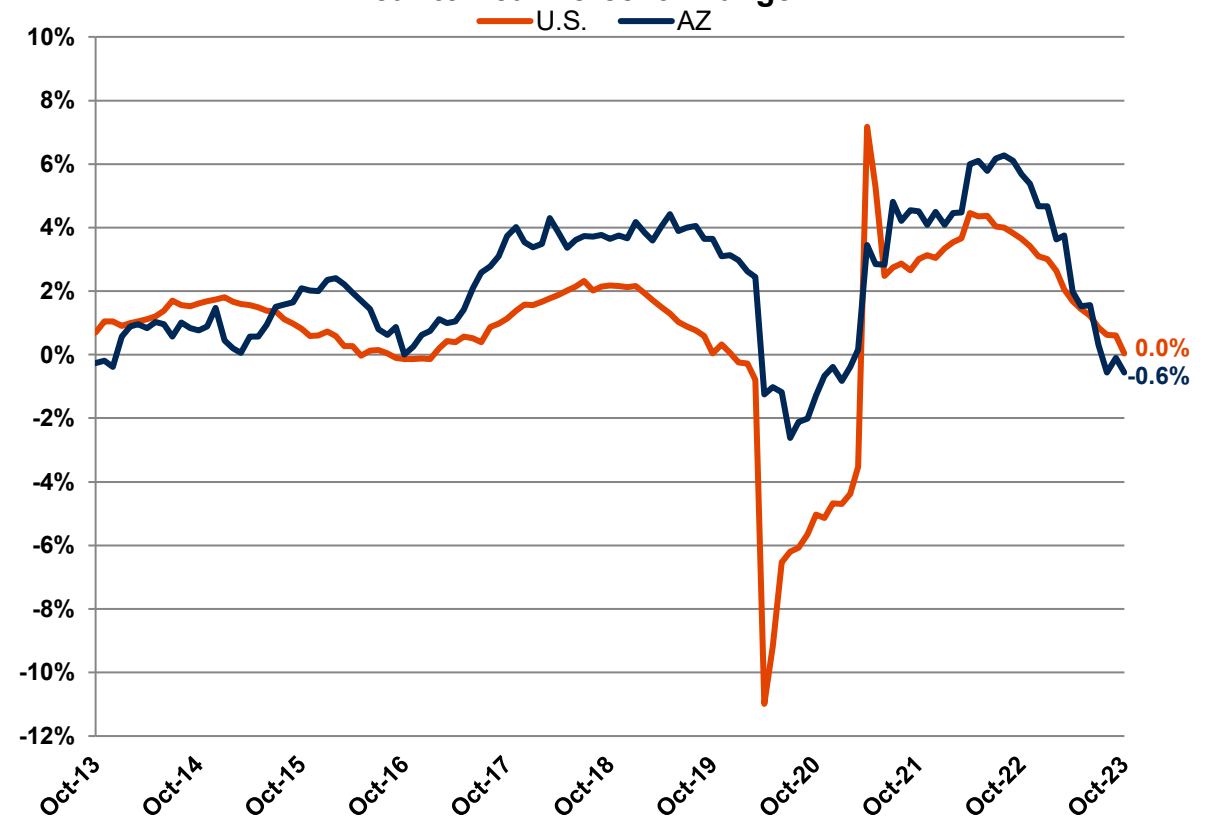
Arizona & U.S. Nonfarm Employment

Year-to-Year Percent Change



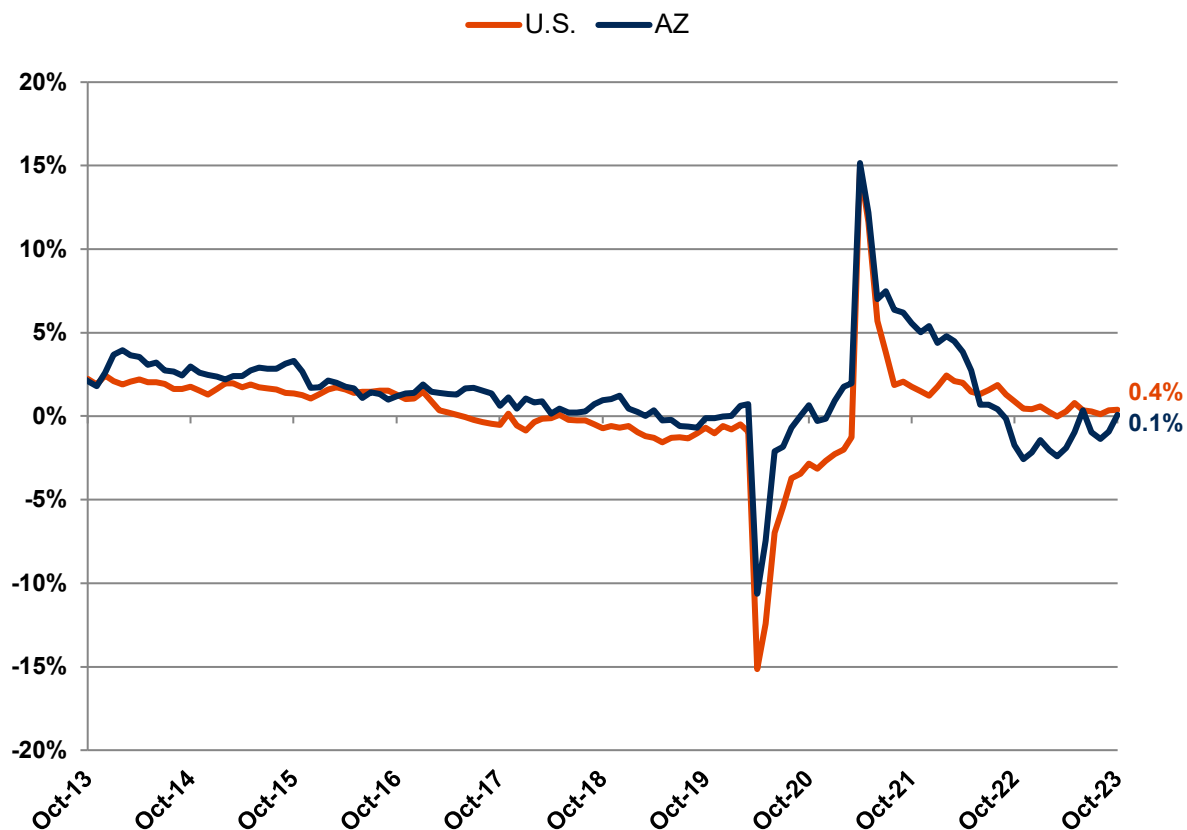
Arizona & U.S. Manufacturing Employment
Year-to-Year Percent Change



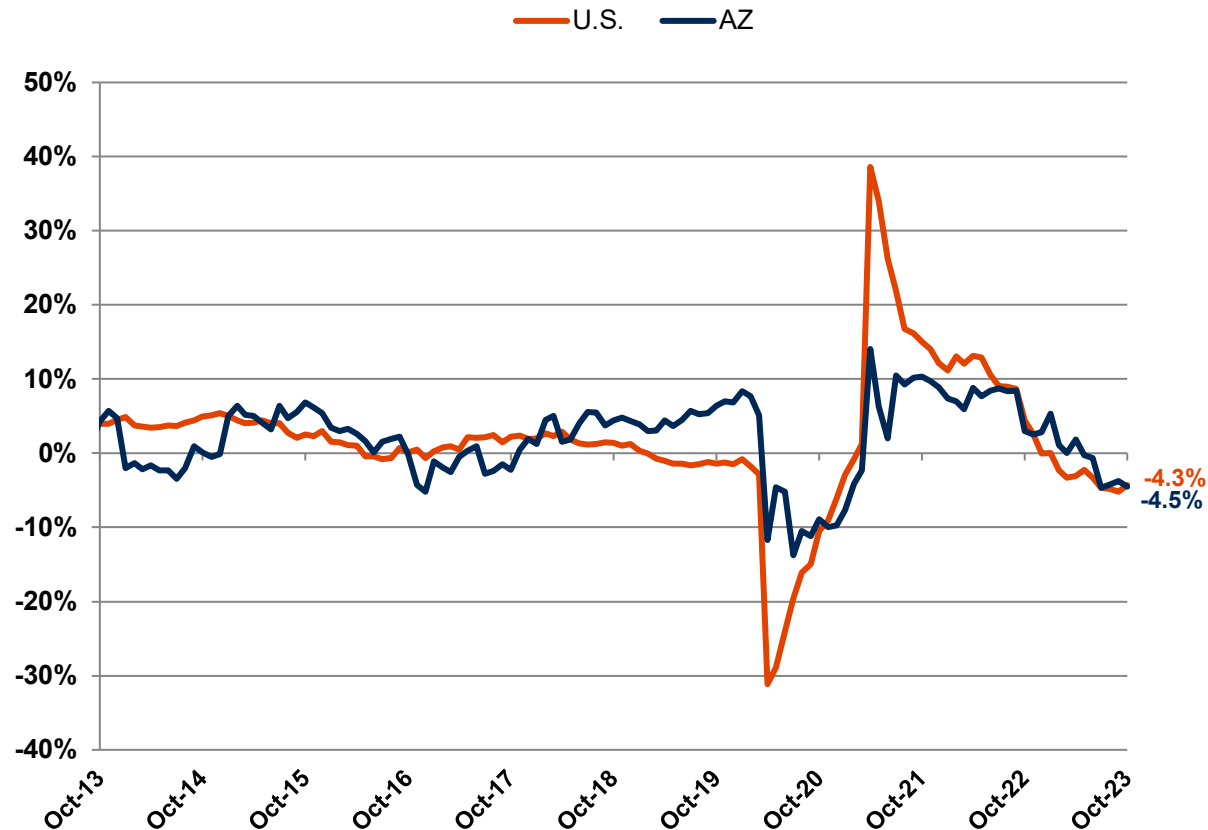

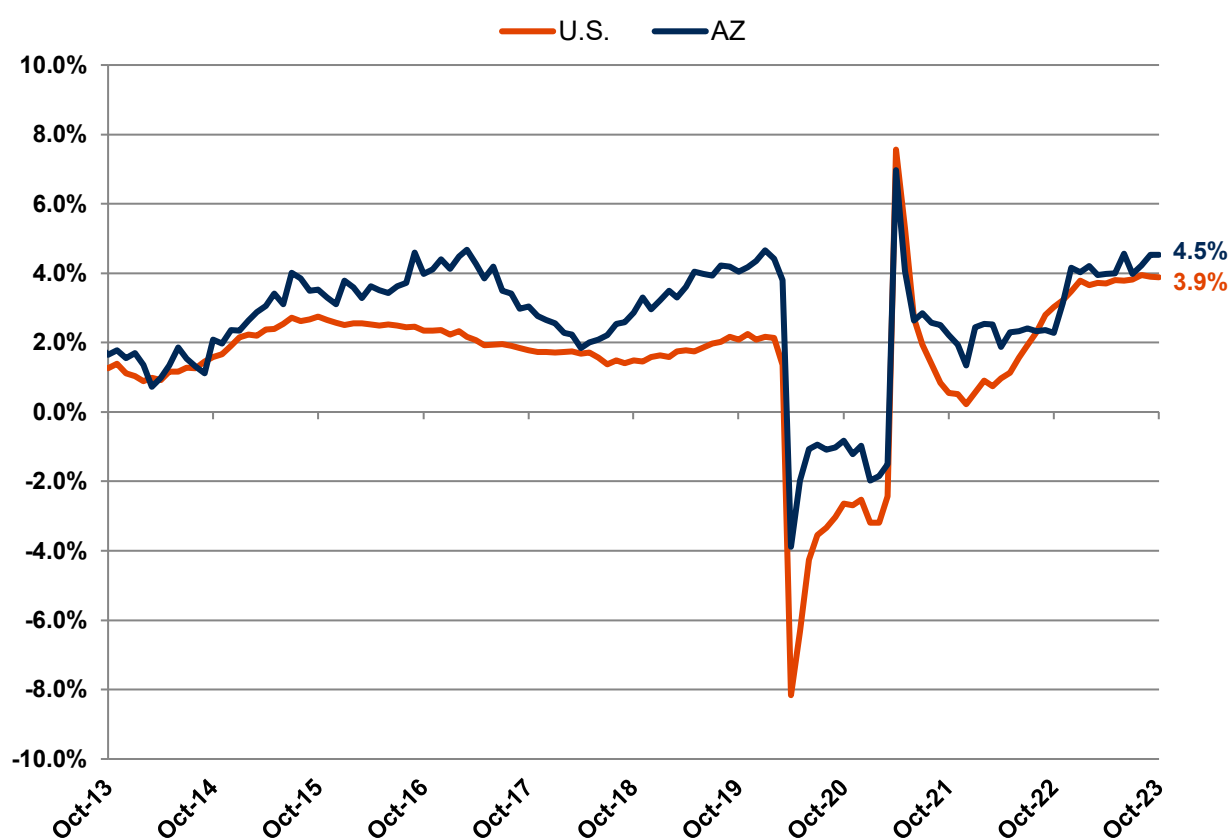
Arizona & U.S. Retail Trade
Year-to-Year Percent Change



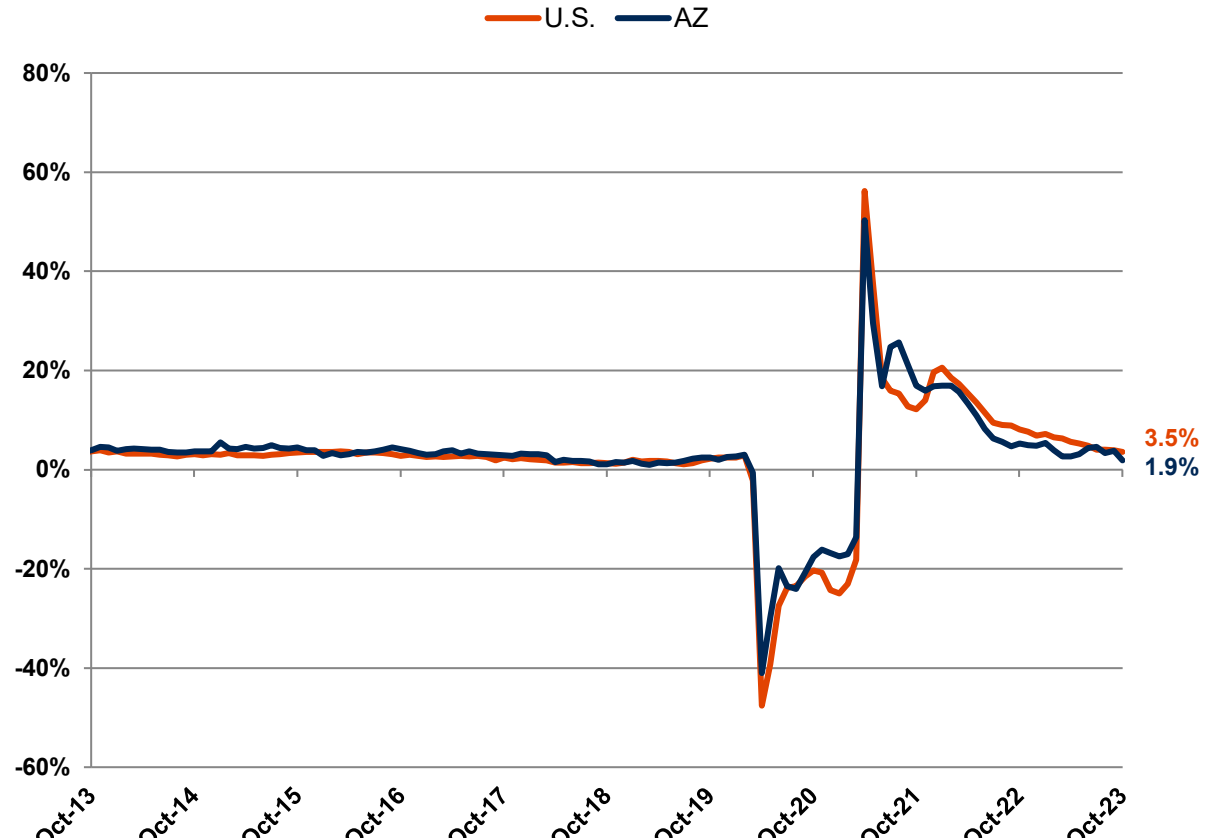
Arizona & U.S. Employment Services
